Learning Centre, ALU) HELINA EDUCATIONAL TRUST (Trust) herein referred to
as Party No.(2) on _____(Date).

1. Whereas Party No.(1) has proposed to offer its College to permit Party No.(2) to conduct Alagappa University Distance Education Courses in the College Premises only without disturbing students of both parties.

2. In case of any dispute, difference of opinion arises between the parties, the same will not bind or affect either directly or indirectly the Alagappa University. In no way, the Alagappa University is liable or responsible for any untoward incidents or happenings. Furthermore, the Alagappa University is not responsible for any dues to be paid to the 1st party.

3. The College and its staff both teaching and non-teaching have no objection to conduct the classes by the 2nd party and the 1st party hereby promises to co-operate with the 2nd party to conduct its classes successfully in every aspect. The 1st party has permitted the 2nd party to affix or exhibit flex boards, or signings or notices or its kind relating to the classes to be conducted by the 2nd party. The 1st party has no objection to exhibit the symbol, letters, emblem of the University in the programme to be conducted by the 2nd party in the college premises. Either the 1st party or 2nd party has no any personal right to implead themselves or establish their names in the programmes conducted in the college.
4. The 2nd party cannot have any personal right over the premises to be let by the 1st party. Likewise, the 1st party cannot have any individual right over the programmes conducted by the 2nd party on behalf of the University.
5. During the academic year, both the parties are not entitled to revoke or cancel or alter this agreement since it would affect the students.
6. The 2nd party shall not conduct any course which are not approved or instructed by the University.
7. Any expenses, loss or injury, claim, dues including rent, transport facility, consumption of electricity, conveyance, damages, theft if any, shall be incurred by the 2nd party and shall be borne only by the 2nd party.
8. During the tenure of the academic year, the 1st party shall not cancel, revoke or alter this agreement. The minimum tenure would be for a period of three year and thereafter it is subject to renewal by mutual consent.
9. Both the parties shall send an attested copy of this agreement to the Registrar, Alagappa University. The 2nd party undertakes to maintain discipline and order at the time of conducting programmes or classes in the college of the 1st party. If any changes, alterations, renewals etc. are made in the agreement, true copy of the same shall be sent to the University.

The 2nd party is entitled to conduct the classes, programmes only in the location described below:


