### MEMORANDUM OF UNDERSTANDING

This memorandum of Understanding is entered on this 13<sup>th</sup> September 2021 between Annai Hajira Women's College, Melapalayam, Tirunelveli-627005 hereinafter called the first party represented by The Principal, Annai Hajira Women's College, Melapalayam, Tirunelveli, Tamil Nadu – 627005

AND

Rosemary College of Arts & Science, Caussanelpuram, Konganthanparai Post, Nagercoil Road, Tirunelveli 627 007, hereinafter called the second party represented by The Principal

#### 1. Preamble

Annai Hajira Women's College, Melapalayam, Tirunelveli-627005 offers a multifaceted academic credibility to the stakeholders who come from various walks of life. Specifically, this institution enforces unique strategic expertise in order to foster academic creditworthiness, in addition to catering

to the needs of the students to update the knowledge of Technology through the personality –interaction with industries.

**Rosemary College of Arts & Science, Caussanelpuram, Konganthanparai Post, Nagercoil Road, Tirunelveli 627 007** offers Under Graduate and PG Programme. The College strives for catering the needs of the students by creating and promoting interaction with the industries to provide up-to-date training and knowledge to the faculty and students.

## 2. Purpose

The purpose of the Memorandum of Understanding is to ensure various Collaborative Quality Initiative Programmes initiated by both the IQACs and measure their successful implementation between first and second party and share their knowledge and skills available in both the institutions for the benefit of enhancing the quality of teaching and learning. This Memorandum of Understanding will also take up joint Consultations and Projects to the Institution.

### 2.1 Projects

The first party and second party shall mutually offer projects to the UG, belonging to both the institutions for a period mentioned therein sufficient to complete the project. Two experts each from **Annai Hajira Women's College, Melapalayam, Tirunelveli-627005** and **Rosemary College of Arts & Science, Caussanelpuram, Konganthanparai Post, Nagercoil Road, Tirunelveli 627 007** shall guide their projects as and when required.

### 2.2. Miscellaneous

In addition to the objectives discussed above, the collaboration shall also include the following

- a. Interaction with the experts in the department concerned so as to pave the way for a knowledge platform for both faculty and students.
- b. Offering expert lectures from one side to the other.
- c. Offering valuable inputs to the institution as a feedback from the fellow institution in respect of recent trends and developments in the area of interaction.
- d. Both the colleges shall collaborate and cooperate in Placement Activities such as Soft skills Training and On-campus recruitment process.
- e. Community Programmes: Social Awareness Events conducted for the rural community, Assistance of labour for a specific period and Health Awareness supplementing with recent medical Assistance could be carried out as Extension Programmes.

- f. The Student Exchange Program come into effect wherein students from **Annai Hajira Women's College, Melapalayam, Tirunelveli-627005** could receive expertise from faculty concerned in **Rosemary College of Arts & Science Tirunelveli 627 007** and vice versa.
    - g. Faculty Exchange program could be brought into action upon the signing of the authorities concerned. Faculty from **Annai Hajira Women's College, Melapalayam, Tirunelveli-627005** render and share knowledge and expertise to faculty in **Rosemary College of Arts & Science, Tirunelveli 627 007** and vice versa
3. Exchange of information and documents  
Both the institutions shall arrange for the exchange of information and documents concerning matters of common interest.
4. Co-operation  
Whenever desirable, both parties may seek each other's co-operation with a view to promoting the development of collaborative activities in the field of common interest
5. Amendments  
Both parties may request the present Memorandum of Understanding be amended. Any such amendments shall be adopted by mutual consent. Whenever required, an exchange of letters will detail the implementation of the article
6. Termination  
This MOU shall be effective from the date of its approval by competent authorities at both ends. The duration of the MOU shall be for a period of **5 years** from the effective date. Either party may terminate the present Memorandum of Understanding by giving a written notice three months in advance to the other party. The obligation on the parties under the terms of their Memorandum of Understanding shall be fulfilled within three months notice period. The final obligation between the parties will also be settled within the notice period

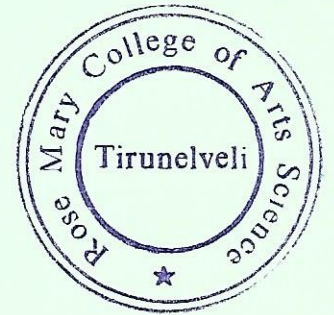
